I found this information in an email. I've mentioned that the railroads played an enormous part in the development of Stephenson County. This explains some of that history. The Jane Addams trail was the northern railroad connection to Wisconsin, and paddlers will see remains of a railroad bridge when paddling from Brewsters Landing. This information is from a document called JATWAYFINDERHISTORY, written 10/16/01.

In 1887 the Illinois Central ran a line north from Freeport to Madison, Wisconsin. The line ran through Scioto Mills and Red Oak. At Red Oak, the Illinois Central built a junction station where the line branched. The northern branch, running through Buena Vista and Orangeville, became known as the Madison branch of the Illinois Central Railroad. This branch is what now constitutes the Jane Addams Trail.

The route closely followed Richland Creek, which has its headwaters just south of Monroe, Wisconsin. This route was chosen for three reasons. First, building a rail line on level ground made good economic sense. Second, this path is a relatively straight north-south path between Monroe and Freeport. And third, the railway intended to make a profit from transporting passengers and freight. Building the line to connect the municipalities along the way was a sound economic decision.

The Richland Waterway was ideal for the early construction of mills, and several municipalities grew up around these mills. Between the Wisconsin and Illinois state border and Freeport, five mills and resultant towns were established on the banks of the Richland long before the coming of the rail line, and the railroad established stations at four of these five towns.

By 1888 there were three major railroads, with freight houses, shops, yards, and station houses, competing in Freeport. The rate wars that occurred in these years resulted in the Illinois Central Railroad building its own line directly from Freeport to Chicago. The Illinois Central could now compete directly with the Chicago North Western for the Rockford and Chicago traffic with a shorter and faster line.
