Plans are being made for the 2025 paddling season. The first item is to ckeck the launch sites for possible repairs and/or maintence. We know the gangway at McConnell needs stain and have arranged that work. A burn at Atten's was supposed to be scheduled. As of April 6th, that hasn't happened. Most notably, the excavator and loader are gone, relocated, making some people happy. The supply of rip-rap from Pecatonica remains and will hopefully be placed to prevent errosion at the overlook sites. People are using this site and that makes all the work worthwhile. The original site plan shows a walking path from the parking lot, walking just north of the tree line, toward the bridge, then north, parallel to the road, then west and back to the parking area.

Once again the IDNR did not say "yes" to awarding a BAAD Grant for the construction of a motorboat launch ramp to be constructed at Atten's Landing. There is no public launch on the Pecatonica River between Freeport and Pecatonica. There is a cost for appling for this grant and FPRF has covered the cost of submitting each of the applications. That's how strongly we feel that a launch is needed in that area. The Winnebago County Fair-Ground, in Pecatonica is the closest public launch.

With the closing of the former VFW launch site, FPRF is attempting to determine a possible replacement launch location. One may be possible along the Pecatonica Prairie Path. An alternative might be near Ridott. The Pecatonica Prairie Path goes througt Ridott just north of the Post Office. Any questions?
